

We Take Your Privacy Seriously

The protection of your private sphere is an important matter to us when we process your personal data. When you visit our website, our web server saves as standard the IP of your internet service provider, the website where your visit to our site originated, the pages of our site that you visit and the date and duration of your visit. This information is mandatory for the technical transmission of the websites and secure server operation. These data are not analysed in personalised form.

If you provide any data to us using a contact form, these data will be stored on our servers as part of the data backup. We use your data solely and exclusively for the processing of your request. Your data are treated in strictest confidence. They will not be made available to third parties.

Personal Data

Personal data are any data related to you personally. They include your name, address and email address. You are not required to reveal any personal data to obtain access to our internet site. In some cases, we will require your name and address along with some additional information if we are to be able to offer you the requested service.

We will also need these data if you want us to provide information material to you or when we answer your queries. We will, however, always expressly point this out to you. Moreover, we store only the data that you have communicated to us automatically or voluntarily.

When you use one of our services, we generally store only the data that are required for us to offer our service to you. We may possibly ask you for more information, but your disclosure of such information is voluntary. Whenever we process personal data, we do this so that we can offer our service to you or realise our commercial goals.

Automatic Storage of Non-personal Data

Whenever you visit our internet site, we may, under certain circumstances, store certain information for administrative and technical reasons. Such information may include the type and release of the browser you are using, the date and time of the access and the IP address.

Any such data will be anonymised, however, and used solely for statistical purposes or for the improvement of our internet and online services. These anonymised data are stored – separately from personal data – on secure systems and cannot be associated with any specific persons. This means that your personal data are protected at all times.

Cookies

When you visit our internet sites, it is possible that we will store information on your computer in the form of cookies. Cookies are small files transmitted to your browser by an internet server and stored on your computer's hard drive. Only the internet protocol address is stored at this time, not any personal data. The information stored in the cookies enables us to recognise you automatically the next time you visit our site, enhancing your convenience when using the site.

Naturally, you can also visit our site without accepting any cookies. If you do not want your computer to be recognised when you come back for your next visit, you can refuse to accept the cookies by changing the settings in your browser to prevent the acceptance of cookies. See the operating instructions for your specific browser to find out how to change these settings. If you do not accept cookies, however, it is possible that there will be limitations on your use of some of the sections of our internet sites.

Use of Google Analytics with Anonymisation Function

On our website, we are using Google Analytics, a web analytics service provided by Google Inc., 1600 Amphitheatre Parkway, Mountain View, CA 94043 U.S.A., hereinafter „Google“. Google Analytics uses so-called „cookies“, i.e. text files saved to your computer for the purpose of analysing your use of the website.

Information generated by these cookies is transmitted to and stored by Google in the U.S.A. – e.g. the time of day/date, location and frequency of your visit to the website, including your IP address.

Our website uses Google Analytics with the extension „_gat._anonymizeIp“. In this case, your IP address is already truncated and thus anonymised by Google within the Member States of the European Union or in other states party to the Agreement on the European Economic Area.

Google will use this information to evaluate your use of our website, compile reports for us on website activities and provide other services relating to website use and internet use. Also, Google will transmit such information to third parties where applicable if this is legally prescribed or as far as third parties process such data on Google's behalf.

By its own account, Google will in no case associate your IP address with other Google data. You may prevent the installation of cookies by an appropriate setting in your browser software; please note, however, that by doing so you might not be able to fully use all functions of our website.

Furthermore, Google offers a deactivation add-on for the most commonly used browsers, thus giving you more control over which data will be recorded by Google in connection with the websites you visit. The add-on tells JavaScript (ga.js) of Google Analytics that no information regarding the website visit is to be transmitted to Google Analytics. However, the Google Analytics deactivation add-on for browsers does not prevent the transmission of information to us or to other web analytics services possibly used by us. If you visit our website via a mobile terminal device (smartphone or tablet), you must **click this link** instead to prevent tracking by Google Analytics within this website in the future. This is also a viable alternative to the above-mentioned browser add-on. Clicking this link will set an opt-out cookie in your browser which is only valid for this browser and this domain. If you delete the cookies in this browser, the opt-out cookie will be deleted as well, so that you have to click on the link again.

If you consented that your web and app browser history will be associated by Google with your Google account and that information from your Google account will be used for personalised advertising, Google will use your data together with Google Analytics data to generate target audience lists for cross-device remarketing. To this end, Google Analytics will first record – on our website – your Google-authenticated ID which is connected with your Google account (thus personal data). Subsequently, Google Analytics will temporarily associate your ID with your Google Analytics data to thus optimise our target groups.

If you disagree with this, you may stop it by using appropriate settings in your Google account via „My Account“.

These cookies lose their validity after 30 days and are not used for personal identification. Use of AppNexus

Retargeting with Ve Interactive

Our website uses retargeting technologies from Ve Interactive Limited, 15-19 Bakers Row, London, EC1R 3DG, England (formerly GDM Digital). It uses Ve Interactive Java snippets, which run on your computer during your use of the website and enable an analysis of your use of the website and interim storage of any entries in forms on the internet site. As a rule, the information regarding your use of this website generated in this way is transmitted to a Ve Interactive server in London and stored there for a maximum of 30 days. Ve Interactive uses this information on our behalf to notify you by email of the temporary storage of the data in the event that the connection to your computer becomes unstable or is lost. The data your browser provides within the scope of VeApps are not merged with other data of the internet site. In compliance with applicable data protection laws, only absolutely anonymous cookies are stored on your computer; they are deleted after 30 days. Affilex

No permanent link going beyond this scope will be created between your customer account and your Facebook account. Facebook's Custom Audiences Pixel

In order to present visitors of our website with interest-based advertisements while they are on Facebook, we use „Custom Audiences Pixel“ by Facebook Inc., 1601 S. California Ave, Palo Alto, CA 94304, U.S.A. („Facebook“). To this end, we implemented a pixel by Facebook on our website through which a direct connection to the Facebook servers is established when our website is visited. The information is transmitted to the Facebook server that you visited our website, and Facebook will associate this information with your personal Facebook user account. Use of YouTube in the Extended Privacy Mode

We use the services provided by YouTube to incorporate videos on the site. The videos are embedded in the extended privacy mode. Like most websites, however, YouTube also uses cookies to collect information about the visitors to its internet site. Among other purposes, YouTube uses this information to collate video statistics, to prevent fraud and to improve user friendliness. It also results in the creation of a connection to the Google DoubleClick network. Starting the video may trigger further data processing operations.

Newsletter

We are using the so-called double opt-in procedure for mailing the newsletter, i.e. we will only send you a newsletter by email after your prior explicit confirmation that we are to activate the newsletter service. We will then send you an email message in which we ask you to confirm that you want to receive our newsletter by clicking on a link included in this email. For your subscription to our newsletter, we will store your IP address and the date of your subscription. This storage is used only for verification in the event that a third party misuses your email address to subscribe you to our newsletter distribution without your knowledge or your authorisation. Should you decide later on that you no longer want to receive our newsletter, you may object to it at any time, without incurring more than the transmission costs according to the basic rates in this respect. It will be sufficient to send a message in text form (e.g. email, fax, letter) either to us or to our data protection officer. Of course, every newsletter also has a link for unsubscribing.

The newsletters are mailed by using „MailChimp“, a newsletter distribution platform by the U.S. provider Rocket Science Group, LLC, 675 Ponce De Leon Ave NE #5000, Atlanta, GA 30308, U.S.A. The email addresses of the recipients of our newsletter, as well as their additional data as described within these provisions are stored on MailChimp servers in the U.S.A. MailChimp uses this information on our behalf for the distribution and evaluation of the newsletters. According to their own information, MailChimp can furthermore use this data for optimising or improving its proprietary services, e.g. regarding the technical optimisation of mailing and the presentation of newsletters, or for economic purposes in order to determine which countries the recipients are from. However, MailChimp is not allowed to use the data of our newsletter recipients to contact them on its own account; and it is also not allowed to transmit such data to third parties. MailChimp is „Privacy Shield“ certified, thus pledging to comply with EU data protection requirements. You may [view here](#) the MailChimp data protection regulations.

The newsletters contain a so-called „web beacon“, i.e. a pixel-sized file that is retrieved from the MailChimp server when the newsletter is opened. Within the scope of this retrieval, technical information will be collected – such as information on the browser and your system, as well as your IP address and the point in time of the retrieval. This information is used for the technical optimisation of either the services based on technical data or the target groups and their reading habits based on their location of retrieval (which may be pinpointed through the IP address) or based on the access times. Statistical surveys also include the information as to whether the newsletters are opened, when they are opened and which links have been clicked. For technical reasons, this information can actually be allocated to the individual newsletter recipients. However, it is not our endeavour nor that of MailChimp to monitor individual users. Much rather, such evaluations allow us to determine our users' reading habits and tailor our content to them or mail different content according to the interests of our users.

Sweepstakes

ONLINE Schreibgeräte GmbH stores and uses the participant's personal data (name, address, email, telephone, gender, date of birth, country) for processing the „Rabazzi“ campaign and any sweepstakes taking place or, respectively, for mailing information on offers or promotions/product information (voluntary information). Processing these data is required for handling the campaigns/sweepstakes. If the information is not provided, contract implementation will not be possible. Within the campaign/sweepstakes, it may be necessary to transmit the member's personal data to third parties. If ONLINE Schreibgeräte GmbH obtains consent of the data subject regarding the processing operations of personal data, Art. 6 para. 1 letter a of the EU General Data Protection Regulation (GDPR) serves as the legal basis for processing personal data (mailing offers or promotions/product information).

Art. 6 para. 1 letter b GDPR is used as the legal basis for processing personal data which are required for the performance of a contract (campaign/sweepstakes) whose contract party is the data subject. This also applies for processing operations which are required for the implementation of pre-contractual measures, as well as for the transmission of personal data to third parties for contract performance. Art. 6 para. 1 letter c GDPR is used as the legal basis as far as processing of personal data is required for compliance with a legal obligation to which the company, ONLINE Schreibgeräte GmbH, is subjected.

These data are deleted after termination of the sweepstakes / after mailing the surprise package as far as the data are not required or used on the basis of a submitted and non-revoked declaration of consent, on the one hand, for the transmission of ONLINE Schreibgeräte offers and ONLINE Schreibgeräte product information via email, or as long as statutory storage periods exist, legal claims may be lodged under the „Rabazzi“ campaign/the sweepstake, or if other legitimate reasons justify further storage.

In connection with data processing, the member has the following legal remedies available, each in accordance with statutory provisions: the right of information about the data concerning the member, correction, erasure or restriction of processing, or objection against processing, the right of data portability, as well as filing a complaint with a supervisory authority.
